Definition	Maximum Charge per Student	Due
<u>Charges</u>		
This term refers to the <i>maximum anticipated costs</i> of extra activities throughout the school year. Participation in extra activities that incur a charge are an extra cost option that enhances the curriculum learning process, but participation is conditional on payment. The total amount charged for the entire year will not exceed the totals in this document. If a particular event listed in this table does not occur then no charges for that event will apply. The estimated costs are at an upper limit and will not exceed this amount. The 2024 charges, which have been approved by the School Board, are as follows.		
<u>Interm Swimming Years PP – 7</u> Children will participate in Interm Swimming lessons.	\$60	As they occur
